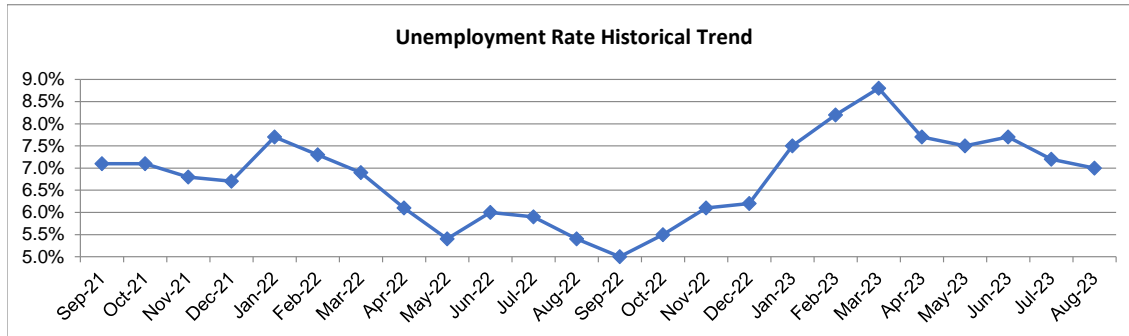


IMMEDIATE RELEASE
 MADERA METROPOLITAN STATISTICAL AREA (MSA)
 (Madera County)

The unemployment rate in the Madera County was 7.0 percent in August 2023, down from a revised 7.2 percent in July 2023, and above the year-ago estimate of 5.4 percent. This compares with an unadjusted unemployment rate of 5.1 percent for California and 3.9 percent for the nation during the same period.
